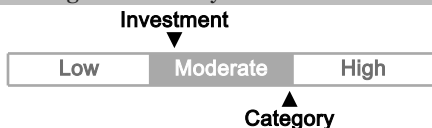

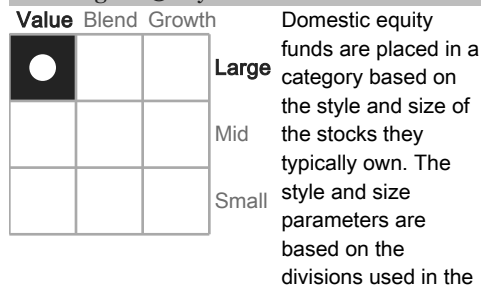

Description / Objective

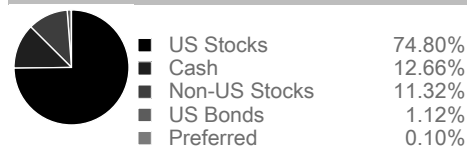
