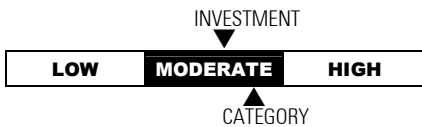

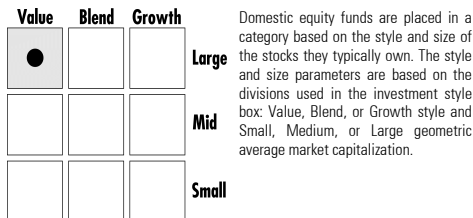

**DESCRIPTION/OBJECTIVE**

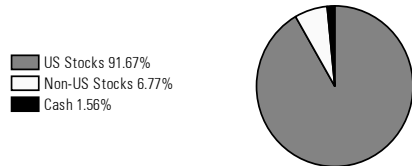
