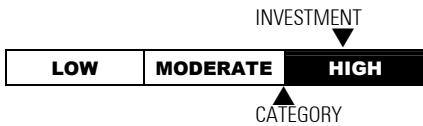

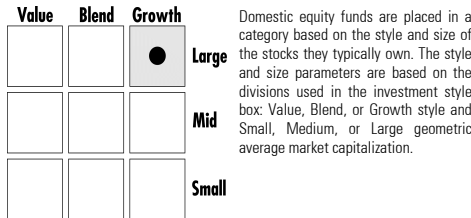

DESCRIPTION/OBJECTIVE

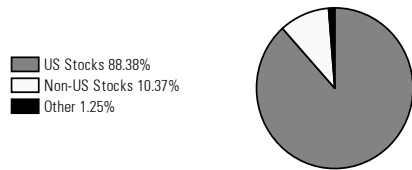
