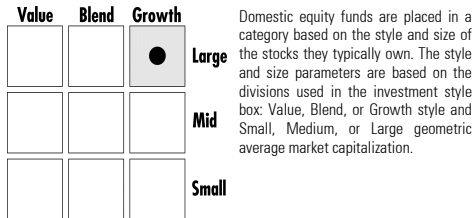

DESCRIPTION/OBJECTIVE

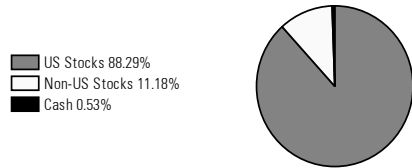
