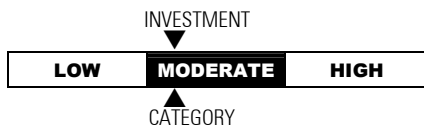

DESCRIPTION/OBJECTIVE

The investment seeks growth, income and conservation of capital. The underlying American Funds represent a variety of fund categories, including growth funds, growth-and-income funds, equity-income funds, balanced funds and fixed income funds. The fund categories represent differing investment objectives.
